RESOLUTION Resolution Number: 2011-10-20-A

Establishing the District Fee and Surcharge Schedule

WHEREAS, the Legislature of the State of Texas created the Texana Groundwater Conservation District in 2001 by the 77th Texas Legislature, regular session, enacting SB 1911, May 17, 1999 and passed the House with amendments on May 28, 1999. This act is recorded in Chapter 1294 of the Acts of the 77th Texas Legislature. The District was confirmed through a referendum of the voters of Jackson County; and


WHEREAS, The Texas Water Code has delegated to the District the power to make and enforce rules, including the ability to establish and prescribe reasonable fees and surcharges; and

WHEREAS, the District has adopted District Rules that became effective upon approval of the District Management Plan by the Executive Administrator of the Texas Water Development Board and said rules provide for the establishment of a schedule of fees and surcharges by resolution:

NOW THEREFORE BE IT RESOLVED THAT:


The District establishes the fees and surcharges of the District as described in the attached fee and surcharge schedule and that the schedule becomes effective upon approval of this resolution. As provided by the District Rules, all grandfathered and exempt-use wells are exempt from the fee schedule except for transport fees and surcharges.

Fee and Surcharge Schedule

District Fees

Drilling permit application without variance request:

1. \$100.00 per application upon submittal.

Operating permit application without variance request:

1. \$100.00 per application upon submittal.

Drilling permit application with variance request(s):

1. \$1,000.00 per application with variance request upon submittal;
2. Remaining balance of any costs incurred by the TGCD associated with outside technical review of application prior to scheduling and publishing notice for any public hearings.

Operating permit application with variance request(s):

1. \$5,000.00 per application with variance request upon submittal;
2. Remaining balance of any costs incurred by the TGCD associated with outside technical review of application prior to scheduling and publishing notice for any public hearings.

Transport permit applications:

1. \$5,000.00 per application upon submittal;
2. Remaining balance of any costs incurred by the TGCD associated with outside technical review of application prior to scheduling and publishing notice for any public hearings.

Fee Refund

The General Manager shall determine the consultation costs incurred in the processing, evaluation, and consideration of a permit application and refund any remaining portion of any fee after final disposition of the associated application.

Export Surcharges

\$0.025 per 1000 gallons (\$8.15 per acre-foot) of water transported or exported from Jackson County.
